ON 4/12/16 AROUND 1:45 AM I SGT SHARP WAS TRAVELING WEST ON HWY 181 IN BASSETT WHEN I OBSERVED A SILVER SILVERADO TURN SOUTH ONTO CR 259. I OBSERVED THIS VEHICLE WAS TRAVELING ON THE FAR LEFT SIDE OF THE ROADWAY. I ALSO OBSERVED THIS VEHICLES LICENSE PLATE WAS DIRTY AND COULDN'T MAKE OUT THE LAST THREE CHARACTERS. I INITIATED MY EMERGENCY LIGHTS AND STOPPED THIS VEHICLE ABOUT A QUARTER MILE SOUTH ON CR 259. I THEN MADE CONTACT WITH DRIVER HOLLY JENNINGS. MS JENNINGS ADVISED THAT SHE WAS JUST GOING TO HER FRIENDS HOUSE DOWN THE ROAD. I ASKED HER WHO HER FRIEND WAS AND SHE DIDNT ANSWER ME. I ASKED HER AGAIN AND SHE STATED "THE HOUSE DOWN ON THE VERY END ON THE RIGHT". THIS SPECIFIC HOUSE SHE DESCRIBED IS WELL KNOWN TO THE SHERIFF DEPT PERSONNEL FOR HEAVY NARCOTIC USAGE AND GENERAL DISTURBANCE CALLS. I THEN IDENTIFIED THE FRONT PASSENGER AS KACEY HILL. I RETRIEVED BOTH ID'S AND RAN THROUGH DISPATCH. DURING THIS TIME MS JENNINGS ADVISED ME THAT SHE WAS ON ACTIVE PROBATION FOR "TWO DELIVERY CHARGES". I ASKED HER HOW LONG SHE WAS ON PROBATION AND SHE REPLIED "36 MONTHS". DISPATCH THEN CAME OVER THE RADIO AND ADVISED THAT ACIC WAS DOWN DUE TO WEEKLY UPDATES. MS JENNINGS THEN GAVE CONSENT TO SEARCH HER VEHICLE. WHILE SEARCHING HER VEHICLE MS JENNINGS ATTITUDE COMPLETELY CHANGED. SHE WAS VERY UNEASY AND STATED OVER AND OVER "I HAVEN'T CLEANED MY TRUCK OUT SINCE I STRAIGHTENED MYSELF UP". WHILE SEARCHING THE BACK DRIVER SEAT AREA I DISCOVERED A BLACK SUITCASE. INSIDE THE FRONT ZIPPER WAS A METAL ZIPPO LIGHTER TIN. INSIDE THE TIN WAS 1 1/2 XANAX PILLS AND A SUBOXONE PAIN PATCH. I THEN LOCATED A PINK ZIPPERED PURSE. INSIDE THE PURSE WAS A USED METH PIPE WRAPPED INSIDE A BLACK BANDANA. MS JENNINGS CLAIMED OWNERSHIP OF THE SUITE CASE AND PINK PURSE BUT DENIED KNOWING ANYTHING ABOUT THE NARCOTICS OR PIPE. I THEN SEARCHED THE PASSENGER SIDE OF THE VEHICLE. I OBSERVED A BLACK WALLET WITH MS HILLS IDENTIFICATION AND CARDS INSIDE. INSIDE THE WALLET WAS A SINGLE HYDROCODONE PILL. NOTHING ELSE ILLEGAL WAS LOCATED. I THEN CONTACTED POISON CONTROL AND THEY CONFIRMED THE HYDROCODONE PILL AS WELL AS THE GENERIC XANAX PILLS. POISON CONTROL FURTHER ADVISED THAT THE SUBOXONE PAIN PATCH WAS A SCHEDULE 3 DRUG AND COMMONLY USED IN TREATING HEROIN ADDICTS. MS HILL INSISTED FOR ME TO "CUT HER A BREAK" BECAUSE SHE WAS "16 WEEKS PREGNANT". MS HILL WAS CHARGED WITH POCS FELONY AND MS JENNINGS WAS CHARGED WITH POCS WITHOUT A PRESCRIPTION (TWO OFFENSES) AND POIC. BOTH WERE GIVEN AN OSCEOLA COURT DATE OF 4/12/16. NOTHING FURTHER
