SYNOPSIS

ON 07-05-16 CPL. CHRIS ELLIS OBSERVED A SILVER OLDSMOBILE TRAVELING NORTH ON HIGHWAY 297 IN DYESS WITH A CRACK WINDSHIELD AT WHICH TIME EXECUTED A TRAFFIC STOP. UPON MAKING CONTACT WITH THE DRIVER IDENTIFIED AS LACI LUNSFORD THERE WERE OTHER OCCUPIANTS IN THE VEHICLE WHICH WERE IDENTIFIED. CPL. ELLIS THEN OBTAINED WRITTEN CONSENT TO SEARCH THE VEHICLE. UPON SEARCHING THE VEHICLE CPL. ELLIS LOCATED A BACK PACK WHICH ROBERT YERBEY WAS HOLDING WHEN THE TRAFFIC STOP WAS INITIATED. CPL. ELLIS WAS AWARE THAT YERBEY WAS CURRENTLY ON ACTIVE PAROLE. A SEARCH OF THE BACKPACK REVEALED TWO SMALL BAGGIES OF SUSPECTED MARIJUANA AND A SMALL AMOUNT OF SUSPECTED METHAMPHETAMINE. YERBEY WAS THEN PLACED IN CUSTODY FOR POSSESSION OF METHAMPHETAMINE AND POSSESSION OF MARIJUANA. YERBEY WAS ADVISED OF HIS RIGHTS AT WHICH TIME HE AGREED TO SPEAK WITH INVESTIGATORS. YERBEY ADMITTED THAT THE BACK PACK BELONGED TO HIM AND STATED THAT HE HAD IT AT WORK WITH HIS PERSONAL ITEMS INSIDE IT AND OTHER PEOPLE HAD ACCESS TO IT. THE SUSPECTED METHAMPHETAMINE WAS FIELD TESTED WITH A POSITIVE RESULT FOR METHAMPHETAMINE AND HAD AN APPROX. WEIGHT OF 0.4 GRAMS.
