NARRATIVE

ON TUESDAY, JULY 7, 2016 AT APPROXIMATELY 12:55 AM I, CPL. ELLIS, WAS PATROLLING THE AREA BEHIND THE LEVEE IN LUXORA, AR. I OBSERVED A GREY FORD EXPLORER PARKED BEHIND THE LEVEE WITH ITS PARKING LIGHTS ON. THIS AREA IS A VERY WELL-KNOWN PLACE FOR NARCOTICS TO BE USED. I ADVISED DISPATCH I WOULD BE OUT WITH THE VEHICLE AND I MADE CONTACTS WITH THE OCCUPANTS. THE DRIVER WAS IDENTIFIED AS QUINTON FLANAGAN AND THE PASSENGER WAS IDENTIFIED AS CELETA CAGLE. I SPOKE WITH THE OCCUPANTS BRIEFLY AND NOTICED THAT BOTH OCCUPANTS HANDS WERE VISIBLY AND I COULD SEE THEM BREATHING VERY HARD. AT THAT TIME, I ASKED MS. CAGLE TO EXIT THE VEHICLE AND SPEAK WITH ME. WHEN SHE EXITED, I NOTICED HER USE HER LEFT HAND AND PLACE AND UNKNOWN ITEM UP THE LEFT LEG OF HER SHORTS. MS. CAGLE DENIED HAVING PLACED ANYTHING UP HER SHORTS. I THEN ADVISED MS. CAGLE I WAS GOING TO CONDUCT A PAT DOWN OF HER PERSON USING THE BACK OF MY HAND. AT THIS TIME, MS. CAGLE'S LEFT HAND AGAIN WENT UP THE LEFT LEG OF HER PANTS. I THEN INFORMED MS. CAGLE TO PLACE HER HANDS BEHIND HER BACK AND SHE STATED, "I'LL GIVE IT TO YOU." MS. CAGLE THEN RETRIEVED A HYPODERMIC SYRINGE FROM THE LEFT LEG AREA OF HER SHORTS. MS. CAGLE ALSO MADE THE STATEMENT SHE JUST FOUND IT INSIDE HER HOUSE. MS. CAGLE WAS THEN PLACED INTO CUSTODY AND SECURED IN THE REAR OF MY PATROL UNIT. I THEN WALKED AROUND TO THE DRIVER'S SIDE OF THE VEHICLE AND ASKED MR. FLANAGAN TO EXIT. WHEN HE EXITED, I NOTICED AN UNCAPPED HYPODERMIC NEEDLE BETWEEN THE DRIVER DOOR AND THE DRIVER'S SEAT. MR. FLANAGAN WAS THEN PLACED INTO CUSTODY. A SEARCH OF MR. FLANAGAN WAS CONDUCTED, INCIDENT TO HIS ARREST, AND I LOCATED A SINGLE FENTANYL PATCH AND A PRESCRIPTION BOTTLE WITH THE LABEL TORN OFF. MR. FLANAGAN WAS THEN PLACED IN THE REAR OF MY PATROL UNIT ALONG WITH MS. CAGLE. ONCE BOTH SUBJECTS WERE PLACED IN THE REAR OF MY VEHICLE, I INFORMED THEM THAT I HAD JUST CHECKED UNDERNEATH MY BACKSEAT AND THERE WAS NO CONTRABAND UNDER IT. THEN RETURNED TO THE VEHICLE AND BEGAN A PROBABLE CAUSE SEARCH OF THE VEHICLE. ON THE FRONT PASSENGER SIDE, I LOCATED A METAL SPOON WITH WHITE RESIDUE ON IT ALONG WITH WHITE RESIDUE ON THE CARPET OF THE VEHICLE. A SEARCH OF THE DRIVER'S SIDE WAS CONDUCTED AND I LOCATED THE UNCAPPED HYPODERMIC SYRINGE, AN ADDITIONAL HYPODERMIC SYRINGE LOADED WITH SUSPECTED METHAMPHETAMINE IN THE DRIVER'S FLOORBOARD. I THEN LOCATED A BLACK FABRIC GLASS CASE WITH THREE ADDITIONAL HYPODERMIC SYRINGES, ALCOHOL SWABS AND A METAL SPOON INSIDE. A BLUE BACKPACK LOCATED IN THE BACKSEAT OF THE VEHICLE AND WAS SEARCHED AND AN ADDITIONAL WAS LOCATED INSIDE. BY THIS TIME, SGT. TERRY TREADWAY ARRIVED ON THE SCENE TO ASSIST. QUINTON FLANAGAN WAS THEN MOVED TO SGT. TREADWAY'S VEHICLE TO BE TRANSPORTED TO THE MISSISSIPPI COUNTY SHERIFF'S DEPARTMENT. THE VEHICLE WAS TOWED BY MCCARN'S WRECKER SERVICE. ONCE THE WRECKER HAD POSSESSION OF THE VEHICLE, I TRANSPORTED MS. CAGLE TO THE SHERIFF'S DEPARTMENT FOR PROCESSING. WHEN WE ARRIVED AT THE SHERIFF'S OFFICE, I REMOVED MS. CAGLE FROM THE REAR OF THE VEHICLE. AS I DO AFTER EVERY TRANSPORT, I CHECKED THE REAR OF MY PATROL CAR. I THEN LOCATED A PLASTIC BAGGIE CONTAINING SUSPECTED METHAMPHETAMINE DIRECTLY WHERE MS. CAGLE WAS SITTING. MS. CAGLE WAS ESCORTED INTO BOOKING. I THEN ENTERED THE PATROL DIVISION TO EXAMINE THE EVIDENCE. THE PRESCRIPTION BOTTLE WITH THE PILLS WERE CHECKED AND THE SMALL WHITE PILLS, LABELED 381 b, WERE

IDENTIFIED AS 50 MG MEPERIDINE. THESE ARE A GENERIC FOR DEMEROL AND ARE A SCHEDULE 2 CONTROLLED SUBSTANCE. THERE WAS A TOTAL OF FIFTEEN OF THESE PILLS. I THEN CHECKED THE LARGER WHITE PILLS, LABELED 54 163, AND THEY WERE IDENTIFIED AS 100 MG MEPERIDINE AND IS ALSO A SCHEDULE 2 CONTROLLED SUBSTANCE. THERE IS A TOTAL OF TWO OF THESE PILLS. THE FENTANYL PATCH IS ALSO A SCHEDULE 2 CONTROLLED SUBSTANCE. THE SUSPECTED METHAMPHETAMINE RECOVERED FROM THE BACK OF MY PATROL VEHICLE HAD AN APPROXIMATE WEIGHT OF 0.3 GRAMS. QUINTON FLANAGAN WAS PLACED IN JAIL AND CHARGED WITH POSSESSION OF A CONTROLLED SUBSTANCE (METH), POSSESSION OF A CONTROLLED SUBSTANCE (DEMEROL AND FENTANYL) AND POSSESSION OF DRUG PARAPHERNALIA. CELETA CAGLE WAS PLACED IN JAIL AND CHARGED WITH POSSESSION OF A CONTROLLED SUBSTANCE (METH), TAMPERING WITH PHYSICAL EVIDENCE AND POSSESSION OF DRUG PARAPHERNALIA. THE EVIDENCE RECOVERED IN THIS CASE WAS TURNED OVER TO SECOND JUDICIAL DRUG TASK FORCE AGENT WILLIAM SKAGGS.
