ON SATURDAY, JULY 16, 2016 AT APPROXIMATELY 6:48 PM I, CPL. ELLIS, WAS PATROLLING THE AREA OF SOUTH GARDEN DRIVE IN OSCEOLA. I OBSERVED A WHITE CHEVY MONTE CARLO TRAVELING WEST ON SOUTH GARDEN AND PULL INTO A RESIDENCE. I CONTINUED PAST THE VEHICLE AND THEN TURNED AROUND A SHORT DISTANCE LATER. AS I APPROACHED THE RESIDENCE, I NOTICED THE VEHICLE HAD BACKED OUT AND WAS NOW TOWARDS ME. AS I MET THE VEHICLE, I RECOGNIZED THE DRIVER TO BE RICKY FREEMAN. I WAS AWARE THAT FREEMAN'S DRIVER'S LICENSE WAS SUSPENDED. I THEN TURNED MY PATROL UNIT AROUND AND ACCELERATED TO CATCH UP WITH THE VEHICLE. AS THE VEHICLE TRIED TURNING ONTO EAST DRIVE FROM NORTH GARDEN, FREEMAN TURNED INTO THE WRONG LANE OF TRAFFIC AND NEARLY INTO A YARD. AT THAT TIME, I INITIATED A TRAFFIC STOP . THE VEHICLE CAME TO A STOP ON EAST DRIVE AND WEST FORD. I EXITED MY PATROL VEHICLE AND APPROACHED THE VEHICLE. I INFORMED RICKY FREEMAN FOR THE REASON HE WAS STOPPED AND ALSO IDENTIFIED THE PASSENGER AS STEPHANIE WYNNE. WHILE SPEAKING WITH FREEMAN, I DETECTED A STRONG ODOR OF INTOXICANTS COMING FROM THE VEHICLE NOTICED FREEMAN'S EYES WERE BLOODSHOT AND WATERY. I RAN A LICENSE CHECK ON FREEMAN AND VERIFIED HIS LICENSE WAS SUSPENDED AND HAD RECEIVED A PRIOR CITATION ON JULY 12, 2016. I THEN ASKED FREEMAN TO EXIT THE VEHICLE TO PERFORM FIELD SOBRIETY TESTS. THE FIRST TEST WAS THE HORIZONTAL GAZE NYSTAGMUS. FREEMAN THE LACK OF SMOOTH PURSUIT, DISTINT AND SUSTAINED NYSTAGMUS AT MAXIMUM AND THE ONSET OF NYSTAGMUS PRIOR TO FORTY-FIVE DEGREES IN BOTH EYES. FREEMAN DID NOT SHOW VERTICAL NYSTAGMUS. THE SECOND TEST WAS THE WALK AND TURN TEST. THE WALKING PHASE, FREEMAN MISSED HEEL TO TOE AND HE PIVOTED ON HIS TURN. THE FINAL TEST WAS THE ONE LEG STAND TEST. DURING THIS TEST, FREEMAN USED HIS ARMS FOR BALANCE AND HE SWAYED. AFTER COMPLETING THE TEST, FREEMAN WAS PLACED INTO CUSTODY FOR DWI. RICKY FREEMAN WAS ALSO LISTED ON ACTIVE PROBATION. I THEN SPOKE WITH STEPHANIE WYNNE AND SHE ADMITTED RICKY HAD STUFFED A CRACK PIPE BETWEEN THE CENTER CONSOLE AND THE DRIVER'S SEAT. A SEARCH OF THE VEHICLE WAS CONDUCTED AND I RECOVERED A GLASS TUBE WITH BURNT WIRE INSIDE A PAPER TOWEL. THIS ITEM WAS LOCATED BETWEEN THE CENTER CONSOLE AND DRIVER'S SEAT. I THEN RECOVERED A SMALL PIECE OF AN OFF-WHITE ROCK-LIKE SUBSTANCE FROM THE CENTER CONSOLE OF THE VEHICLE, NEAR THE GEAR SHIFT. I THEN PLACED STEPHANIE WYNNE IN CUSTODY ALSO. NOTHING FURTHER WAS FOUND INSIDE THE VEHICLE. ONCE WYNNE WAS PLACED INTO CUSTODY, RICKY FREEMAN MADE THE SPONTANEOUS STATEMENTS, "SHE DON'T KNOW WHAT I DO" AND "ALL THAT STUFF IS MINE". THE SUBSTANCE WAS FIELD TESTED AND TESTED POSITIVE FOR COCAINE BASE. AT THAT POINT, STEPHANIE WYNNE WAS RELEASED FROM CUSTODY AND THE VEHICLE WAS RELEASED TO HER. FREEMAN WAS TRANSPORTED TO MISSISSIPPI COUNTY SHERIFF'S DEPARTMENT FOR A BREATH TEST. ONCE WE ARRIVED, FREEMAN WAS ADVISED OF HIS RIGHTS AND HE AGREED TO TAKE THE TEST. FREEMAN PROVIDED A SAMPLE OF .15. RICKY FREEMAN WAS CHARGED WITH DWI 1ST, DOSDL 1ST, POSSESSION OF A CONTROLLED SUBSTANCE (CRACK COCAINE) AND POSSESSION OF DRUG PARAPHERNALIA. THE EVIDENCE RECOVERED WAS LATER TURNED OVER TO [REDACTED], 2ND JUDICIAL DTF. NOTHING FURTHER AT THIS TIME.
