ON SUNDAY, JULY 17, 2016 AT APPROXIMATELY 1:16 AM I, CPL. ELLIS, WAS PATROLLING THE AREA OF WEST ROSE IN BLYTHEVILLE. I OBSERVED A SUBJECT ON A BICYCLE TRAVELING NORTH ON HARRISON TOWARDS WEST ROSE. I THEN OBSERVED THE SUBJECT TURN RIGHT WEST ROSE WITHOUT STOPPING AT THE STOP SIGN. I THEN TURNED MY PATROL UNIT AROUND AND MADE CONTACT WITH THE SUBJECT ON CENTER STREET AT THE INTERSECTION OF BIRCH STREET. I EXITED MY PATROL UNIT AND MADE CONTACT WITH THE SUBJECT, WHO IDENTIFIED HIMSELF AS STEVEN SMITH. I ADVISED MR. SMITH FOR THE REASON I MADE CONTACT WITH

HIM AND I NOTICED HIS HANDS WERE SHAKING AND HIS VOICE WAS TREMBLING. SMITH THEN ADVISED HE WAS ON PAROLE. I ASKED SMITH TO STEP OFF THE BICYCLE AND HE STATED, "WHY". I INFORMED MR. SMITH BECAUSE I ASKED HIM TO. I AGAIN ADVISED HIM TO STEP OFF THE BICYCLE AND STEP TO MY VEHICLE. SMITH THEN GOT BACK ONTO THE BICYCLE AS IF HE WAS GOING TO FLEE. I THEN GRABBED HIM BY HIS LEFT HAND AND FORCED HIM TO SET THE BICYCLE DOWN. I THEN WALKED SMITH TO MY PATROL VEHICLE AND HE IMMEDIATELY BEGAN TO CRY. I THEN PLACED HIM INTO HANDCUFFS DUE TO HIS ERRATIC BEHAVIOR. A SEARCH OF SMITH'S PERSON WAS CONDUCTED AND INSIDE HIS RIGHT WATCH POCKET I LOCATED A PLASTIC BAG CONTAINING A CRYSTAL-LIKE SUBSTANCE BELIEVED TO BE METHAMPHETAMINE. SMITH WAS THEN PLACED INTO THE REAR OF MY PATROL VEHICLE AND TRANSPORTED TO THE MISSISSIPPI COUNTY SHERIFF'S DEPARTMENT. ONCE WE ARRIVED AT THE SHERIFF'S DEPARTMENT, SMITH ADVISED HE WAS SORRY, HE JUST DIDN'T WANT TO GO TO JAIL. SMITH WAS CHARGED WITH POSSESSION OF A CONTROLLED SUBSTANCE (METHAMPHETAMINE), DISOBEY STOP SIGN, AND ALSO AN ACTIVE ARREST WARRANT FOR VIOLATION. THE EVIDENCE WAS LATER FIELD TESTED AND HAD A POSITIVE RESULT FOR METHAMPHETAMINE AND HAD A PRELIMINARY WEIGHT OF 0.6 GRAMS. THE EVIDENCE WAS TURNED OVER TO [REDACTED], 2ND JUDICIAL DTF. NOTHING FURTHER AT THIS TIME.
