NARRATIVE

AM

ON 9/16/16 AROUND 11:30PM I SGT SHARP OBSERVED A WHITE CHEVROLET TRUCK THAT CONTAINED A WHITE FEMALE AND WHITE MALE. I FURTHER OBSERVED THAT THE FEMALE DRIVER WAS NOT WEARING A SEAT BELT. I THEN INITIATED A TRAFFIC STOP ON THIS VEHICLE ON BROADWAY STREET AND MADE CONTACT WITH DRIVER PATRICIA GRAY AND PASSENGER BILLY HILL. I WAS FAMILIAR WITH MR HILL DUE TO A PREVIOUS METH CONVICTION AND KNEW HE WAS AN ACTIVE PROBATIONER. MS GRAY ADVISED THAT THEY WERE "JUST RIDING AROUND". I THEN RETRIEVED THEIR INFORMATION AND RAN BOTH SUBJECTS THROUGH DISPATCH. DISPATCH THEN CONFIRMED MR HILL'S PROBATION AND ADVISED BOTH WERE CLEAR OF ANY WARRANTS. I THEN OBSERVED AN OPEN BEER CONTAINER IN THE CENTER CONSOLE AREA. THE BOTTLE HAD SWEAT AROUND THE EXTERIOR AND APPEARED TO BE ALMOST FULL. MR HILL STATED "THATS MY BEER, BUT IM NOT DRIVING SHARP". I THEN WALKED TO THE PASSENGER SIDE OF THE VEHICLE. WHILE SPEAKING TO MR HILL I OBSERVED A RED RAG LAYING ON THE CENTER CONSOLE. I FURTHER OBSERVED THE END OF A ROUND GLASS TUBE STICKING OUT FROM UNDERNEATH THAT HAD A COLOR TO IT. IT APPEARED TO BE A USED METH PIPE. SINCE MR HILL WAS ON PROBATION AND THIS OBJECT BEING IN PLAIN VIEW WITH IN ARMS REACH I HAD MR HILL EXIT THE VEHICLE. I THEN RETRIEVED THE METH PIPE. MR HILL THEN STATED "PATRICIA DONT F [REDACTED] G PUT THAT ON ME". I THEN ASKED MS GRAY TO EXIT THE VEHICLE. WHILE DOING SO SHE GRABBED HER PURSE THAT WAS SITTING NEXT TO HER AND ATTEMPTED TO TAKE IT WITH HER. I EXPLAINED THAT I HAD PROBABLE CAUSE TO SEARCH HER PURSE AND TO LEAVE IT IN THE VEHICLE. MS GRAY PLEADED WITH ME NOT TO SEARCH IT. MS GRAY THEN STATED "THERES A LITTLE IN IT, MAYBE A QUARTER. PLEASE LET ME GO". MS GRAY PLEADED SEVERAL TIMES AND BEGAN TO CRY UNCONTROLLABLY. INSIDE THE SIDE ZIPPER POUCH I LOCATED A SMALL BAGGIE OF METH THAT WEIGHED JUST OVER A HALF OF A GRAM (0.56). NOTHING ELSE INSIDE THE VEHICLE WAS LOCATED. THE VEHICLE WAS THEN RELEASED TO MR HILL AT MS GRAY'S REQUEST. MS GRAY WAS TRANSPORTED TO THE DETENTION CENTER FOR POCS METH AND PODP WITH AN OSCEOLA COURT DATE OF 9/19/16. NOTHING FURTHER.
