ON 9/16/16 AROUND 10PM I SGT SHARP OBSERVED A GREEN RIDING LAWNMOWER SITTING ON THE WEST SIDE OF HWY 61. I OBSERVED THAT THIS MOWER WAS RUNNING WITH A UTILITY TRAILER A FEW FEET BEHIND IT. I PULLED UP TO THIS MOWER AND OBSERVED A WHITE MALE LAYING UNDERNEATH IT. I THEN MADE CONTACT WITH THIS INDIVIDUAL JIMMY HOOD. I AM FAMILIAR WITH MR HOOD DUE TO A PRIOR INCIDENT SEVERAL MONTHS AGO. IN THIS PREVIOUS INCIDENT MR HOOD GAVE THE NAME "JIMMY CARR" AND HAD DRUG PARAPHERNALIA ON HIS PERSON. MR HOOD WAS GIVEN A WARNING DURING THIS PRIOR INCIDENT. I ASKED MR HOOD FOR HIS NAME AND HE GAVE ME HIS CORRECT NAME JIMMY HOOD. I ASKED MR HOOD WHAT WAS WRONG WITH HIS MOWER AND HE ADVISED THE CLUTCH SLIPPED OFF. WHILE TRYING TO SPEAK WITH MR HOOD I OBSERVED THAT HE LACKED EYE CONTACT WITH ME AND KEPT TURNING HIS ATTENTION TO THE MOWER. MR HOOD WAS CONSTANTLY MOVING HIS HANDS. MR HOOD THEN PICKED A BLANKET OFF THE GROUND AND COVERED HIS UTILITY TRAILER. I THEN ASKED MR HOOD IF HE HAD ANY WEAPONS ON HIS PERSON. MR HOOD STATED "NO, YOU CAN CHECK ME". BEFORE I HAD A CHANCE TO CHECK HE BEGAN EMPTYING THE CONTENTS OF HIS POCKETS. WHILE HE EMPTIED HIS LEFT I OBSERVED HIM RETRIEVE SOME CASH AND A SET OF KEYS. WHILE DOING THIS HE COVERED A SILVER METALLIC CONTAINER UNDER HIS MONEY. I ASKED HIM WHAT WAS UNDER HIS MONEY AND HE THEN PUT HIS HANDS DOWN AND SAID "WHAT?". I THEN ASKED HIM AGAIN AND HE SAID "NOTHING" AND PUT HIS HAND DOWN BY HIS SIDE. DURING THIS TIME MR HOOD WAS EXTREMELY NERVOUS AND BEGAN TO STUTTER HIS WORDS. I THEN GENTLY GRABBED HIS ARM AND ASKED HIM AGAIN WHAT WAS IN HIS HAND AND HE DROPPED HIS HEAD AND STATED "ITS.....ITS METH". I THEN DETAINED HIM AND OPENED THE CONTAINER. THE CONTAINER HAD A SMALL BAGGIE OF SUSPECTED METH, A SMALL BAGGIE OF SUSPECTED CRACK AND TWO TYLENOL 4 PILLS. I THEN ASKED IF THE OTHER BAGGIE WAS INDEED CRACK AND HE STATED "YES". MR HOODS LAWNMOWER AND TRAILER WERE DROPPED OFF AT A FRIEND'S RESIDENCE AT [REDACTED]. MR HOOD WAS TRANSPORTED TO THE DETENTION CENTER AND CHARGED WITH POCS METH, CRACK-COCAINE AND POCS WITHOUT A PRESCRIPTION WITH AN OSCEOLA COURT DATE OF 9/19/16. NOTHING FURTHER.
