MILLER STREET. I GOT BEHIND THIS VEHICLE AND OBSERVED THAT THE TAG ILLUMINATION LIGHTS WERE DEFECTIVE. I INITIATED A TRAFFIC STOP ON THIS VEHICLE ON HWY 61 SOUTH OF HWY 118. WHILE CALLING THIS TRAFFIC STOP INTO DISPATCH I OBSERVED THE DRIVER FRANTICLY MOVING AROUND INSIDE THE VEHICLE. I OBSERVED THE DRIVER LEAN TOWARDS THE PASSENGER SIDE OF THE VEHICLE AND THEN SIT BACK UPRIGHT AND STARE IN HIS SIDE MIRROR TOWARD MY VEHICLE. I THEN MADE CONTACT WITH DRIVER JEFFERY CRAWFORD. MR CRAWFORD ADVISED THAT HE AND HIS PASSENGER TAMMI WOOD WAS ON THE WAY TO PICK UP HER SON TO TAKE HIM TO THE ER. WHILE SPEAKING WITH HIM MR CRAWFORD APPEARED TO BE EXTREMELY NERVOUS. MR CRAWFORD KEPT MOVING HIS HANDS AROUND AND WOULD MAKE QUICK ERRATIC MOVEMENTS. I THEN ASKED MR CRAWFORD TO THE VEHICLE. I PATTED MR CRAWFORD DOWN FOR WEAPONS AND GAINED WRITTEN CONSENT SEARCH THE VEHICLE. CPL ELLIS ARRIVED ON SCENE AND HAD MS WOOD EXIT THE VEHICLE. AS I OPENED THE PASSENGER DOOR I OBSERVED IN PLAIN VIEW A SMALL BAGGIE OF METH IN THE FLOORBOARD. BOTH MS WOOD AND MR CRAWFORD WERE THEN DETAINED. NOTHING ILLEGAL WAS LOCATED ON EITHER PERSON OR INSIDE THE VEHICLE. MR CRAWFORD TOOK OWNERSHIP OF THE METH. MR CRAWFORD ADVISED THAT HE GAVE ME CONSENT TO SEARCH THE VEHICLE BECAUSE HE THOUGHT HE SUCCESSFULLY THREW THE METH OUT OF THE PASSENGER WINDOW BEFORE MY APPROACH TO THE VEHICLE. MS WOOD'S ACCOUNT OF THIS INCIDENT MATCHED THAT OF MR CRAWFORD'S. MR CRAWFORD ADVISED THAT MS WOOD KNEW NOTHING ABOUT THE METH. MR CRAWFORD PROVIDED A WRITTEN STATEMENT CLAIMING OWNERSHIP OF THE METH AS WELL AS A RECORDED STATEMENT ON MY WATCHGUARD CAMERA SYSTEM. SGT FRAZIER WAS CONTACTED AND ADVISED OF THE SITUATION. MR CRAWFORD WAS TAKEN THE DETENTION CENTER FOR POCS METH WITH AN OSCEOLA COURT DATE OF 10/3/16. NOTHING FURTHER.
