ON 2/6/2017 AT APPROXIMATELY 2130 WHILE ON PATROL ON BETHANY ST IN GOSNELL I NOTICED A SILVER HONDA ACCORD TRAVELING OVER THE POSTED SPEED LIMIT. I THEN INITIATED MY EMERGENCY LIGHTS AND CONDUCTED A TRAFFIC STOP. I THEN MADE CONTACT WITH THE DRIVER MR SAMUEL SING. I THEN ASKED MR SING FOR HIS LICENSE. MR SING PRESENTED AN ARKANSAS "ID ONLY" CARD. I THEN RAN MR SING THROUGH DISPATCH TO HIS LICENSE STATUS. DISPATCH ADVISED MR SING'S LICENSE WERE SUSPENDED AND THAT HE HAD BEEN WRITTEN THREE TIMES PREVIOUSLY IN THE LAST 5 YEARS. DISPATCH ALSO ADVISED THAT MR SING WAS ON ACTIVE PAROLE. I THEN PLACED MR SING IN TO CUSTODY. UPON SEARCHING MR SING IT WAS DISCOVERED THAT HE HAD APPROXIMATELY \$3,500 IN SMALL BILLS ON HIS PERSON. I THEN PLACED HIM IN THE BACK OF MY PATROL CAR. I THEN RESUMED THE SEARCH OF MR SING'S CAR. IN THE GLOVE BOX, I FOUND A PRESCRIPTION PILL BOTTLE WITH NO LABEL THAT CONTAINED WHAT APPEARED TO BE SIXTEEN AND A HALF XANAX PILLS.
