On Thursday, March 2, 2017 at approximately 12:53 AM, I, Cpl. Ellis, was traveling eastbound on Highway 14 into Wilson, AR. I was following a red Chevy Tahoe, Arkansas LPN [REDACTED]. While following the vehicle, I it cross the fog line and then drift back into the center of the roadway and cross the center line. At this time, I initiated a traffic stop and the vehicle came to a stop on Highway 14, just west of Wilson city limits. I exited my patrol vehicle and made contacts with the occupants. The driver was identified as Robin Kemp and the passenger was identified as Kevin Kemp. While I was speaking with them, I noticed Kevin Kemp was chewing a of candy very hard. I also noticed he was extremely fidgety and could not sit still. I ran both subjects through ACIC and learned Kevin Kemp was on active parole and has a search waiver on file. I then asked Mr. Kemp to exit the vehicle and I began speaking with him. Mr. Kemp denied having used any illegal narcotics and denied anything being inside the vehicle. I was then informed that Mr. Kemp had an active warrant with Marked Tree Police Department and they requested me meet them at the county line with him. I then placed him into custody and secured him in the rear of my patrol vehicle. I then made contact with Robin Kemp. While speaking with her, I noticed she was very hesitant about anything illegal inside the vehicle. Ms. Kemp finally admitted that Kevin Kemp had an "eight ball" of meth in a cigarette pack. Ms. Kemp then advised she didn't know where he put the cigarette pack. I then allowed Ms. Kemp to speak with Kevin and he admitted the narcotics were in a Marlboro under the passenger seat. I then began searching the passenger area of the vehicle and located an empty Marlboro Red cigarette pack underneath Kevin Kemp's cell phone in the passenger floorboard. I retrieved the items and inside I located a baggie containing pieces of suspected meth. I also located two pieces of tin foil containing several pieces of suspected meth inside. Nothing further was located inside the vehicle. The vehicle was released to Robin Kemp and Kevin Kemp was transported to the Mississippi County Sheriff's Department for processing. The above evidence was field tested and showed a positive result for methamphetamine and the baggie had an approximate weight of 3.1 grams. Kevin Kemp was placed in jail and charged with Possession of a Controlled Substance (Meth). The warrant from the Marked Tree Police Department could not be obtained at the of this report due to the phone and fax lines being out of service. [REDACTED]
