NARRATIVE

On Sunday, March 26, 2017 at approximately 1:36 AM I, Cpl. Ellis, was stationary on Highway 297. I observed a Jeep Liberty pull up to a known drug house on Oak Street in Dyess, AR. The vehicle was at the residence less than minutes and then left. Through my training and experience, this type of behavior is similar to the purchase of narcotics. The vehicle then turned left and began traveling west on 2nd Street. I was able to catch up with the vehicle on 2nd Street and noticed the vehicle did not have a license plate. At that time, I initiated a traffic stop. I exited my patrol unit and made contact with the occupants of the vehicle. I informed the driver, identified as Raymond Jones, for the reason he was stopped. Mr. Jones provided his proof of insurance and bill of sale for the vehicle. I then recognized the front passenger to be Johnny Holt and the rear passenger to be Robert Yerbey, both of which I have previously arrested for narcotics. While speaking with Jones, I noticed he would not make eye contact with me, his hands were visibly shaking and he was taking very short, shallow breaths. Mr. Holt was extremely talkative to me while I was at the vehicle.

I then asked Mr. Jones to exit the vehicle and a pat down of his person was done with nothing located. Mr. Jones was asked about anything illegal inside the vehicle and he advised there wasn't anything. I then asked Mr. Holt to exit the vehicle and he was checked for weapons with nothing located. I then asked Mr. Yerbey to exit the vehicle and I informed him I was going to conduct a search of the vehicle in his immediate control. Mr. Yerbey was then checked for weapons with nothing located. While searching the back seat area of the vehicle, I located a white pill with the markings "U37". This pill was located between the back seats on the passenger side of the vehicle. After locating this item, I used the markings on the pill to identify it as acetaminophen/ codeine 300mg/ 60 mg. All three occupants were then placed into custody and informed of the item recovered from the vehicle. All occupants denied ownership of the pill. The vehicle was then released to Raymond Jones' family and all three were transported to the Mississippi County Sheriff's Department. Upon arriving at the jail, Mr. Yerbey made the statement that he would take the charge but the pill did not belong to him. Raymond Jones, Robert Yerbey and Johnny Holt were all placed in jail and charged with Possession of a Controlled Substance (Felony) Schedule II. The evidence recovered was packaged and later turned over to [redacted].

After speaking with [redacted], he advised to charge all subjects with Possession of a Controlled Substance without a Prescription. [redacted]. Nothing further at this time.
