On Monday, March 27, 2017 at approximately 12:03 AM I, Cpl. Ellis, was traveling north on Ermen Lane in AR. I observed a black Dodge Neon also traveling north on Ermen Lane. I got behind the vehicle and ran the license plate, [REDACTED], and was informed the registration returned on a maroon Dodge Neon. The vehicle then turned east onto West Semmes and I noticed the windshield was cracked, directly in the driver's line of sight. At that point, I initiated a traffic stop on the vehicle on West Semmes near the intersection of Betty Lynn. I exited my vehicle and made contact with the occupants of the vehicle. I introduced myself and informed the driver, identified as Donald Hampton, for the reason of the stop. I then identified the front passenger as Barbara McKemie. After obtaining their personal information, I had dispatch check for active warrants on both subjects. A short time later, I was informed that both Hampton and McKemie were on active probation and both search waivers on file. At this time, I asked Donald Hampton to exit the vehicle and speak with me. I asked Mr. Hampton where they were coming from and he advised they were coming from a house just south of Osceola from one of Barbara's friends but he didn't know her name. Donald's person was searched with nothing located. I then spoke with Barbara McKemie and she confirmed she is on probation for a Possession of Meth charge. Barbara to be very nervous while I was speaking with her. I noticed she was very vague with her answers and her hands were trembling. I then asked Barbara where they were coming from and she advised they just left Justin Wood's residence. I then asked Barbara to exit the vehicle and have her empty her pockets with nothing located. I then began a search of the vehicle due to both subjects being on probation. I located a pill bottle in Ms. McKemie's purse with the name Jonathan McKemie. Ms. McKemie advised Jonathan is her husband but they are in the process getting a divorce. The prescription label showed the prescription to be for Clonazepam. I opened the bottle and saw the pills were white pills, labeled SG 109. I recovered this item until I finished a search of the vehicle. Nothing further was located inside the vehicle. I was then able to identify the pills as Carisoprodol (Soma) 350mg. I went back and informed Ms. McKemie of what I had located and she stated she found the pills at a house in Dyess, AR and she knew they were somas. I then informed Ms. McKemie she was under arrest for Possession of Controlled Substance without a Prescription. While escorting Ms. McKemie to the rear of my truck, I informed her if she had anything illegal on her person to tell me otherwise she could face additional charges once we arrived at the jail. Ms. McKemie then admitted she had a pipe in her bra. I allowed Ms. McKemie to retrieve the item and she placed in on my vehicle. I then asked Ms. McKemie if she had any methamphetamine on her person and she put her head down. I told her if she had any to give it to me or she would face additional charges once we got to the jail. Ms. McKemie then retrieve a bag from her bra and handed it to me. I then secured Ms. McKemie in the rear of my patrol unit. Donald Hampton was then released from the traffic stop and McKemie was transported to Mississippi County Sheriff's Department. After arriving at the Sheriff's Department, I opened the bag and noticed three individually wrapped bags containing suspected methamphetamine. The suspected methamphetamine was tested and tested positive for methamphetamine and all three bags had a total approximate weight of 4.8 grams. Inside the pill bottle, a total of 12 Carisoprodol pills were located. Barbara McKemie was placed in jail and charged with Possession of a Controlled Substance (Meth), Possession of Drug Paraphernalia and Possession of a Controlled Substance without a Prescription. The evidence was packaged and later turned over to [REDACTED].
